# Warranty Certificate

## **Suntube SSTG/U Series, Gas Fired Infra-Red Low Intensity Stainless- Steel Tube Heater**

The following warranty is applicable to the **SOLARONICS Suntube SSTG/U Stainless Steel Series units** .

### **LIMITED ONE-YEAR WARRANTY**

**SOLARONICS, INC.** hereinafter referred to as the Manufacturer, warrants to the original owner user that all **SOLARONICS** gas infra-red industrial heaters sold by it and all parts thereof are free from defects in material or workmanship under normal use and service. The Manufacturer's sole obligation under this warranty shall be limited to furnishing replacement parts, F.O.B. Rochester, Michigan for one (1) year from date of initial installation of the heater, but not to exceed 18 months from the date of shipment by Manufacturer of the heater, for any parts which the Manufacturer's examination shall disclose to its satisfaction to be defective. Defective parts to be returned to Manufacturer, transportation charges prepaid.

### **LIMITED FOUR-YEAR ADDITIONAL WARRANTY (TUBES)**

In addition to the above mentioned one-year warranty, the Manufacturer warrants to the original purchaser of any Solaronics Suntube A.G.A./ CGA certified industrial heating gas-fired infra-red heater that it will at any time during the next four years following the expiration of the one-year warranty, furnish replacement of combustion chamber & heat exchanger tubes, the infra-red generating surface (exclusive of controls and hardware), F.O.B. Rochester, Michigan, for any tubes which are proved to be defective in material or factory workmanship. The Manufacturer's sole obligation under this warranty shall be limited to furnishing tubes. This four-year additional warranty covers the tubes only and does not cover labor or transportation charges.

### **LIMITED NINE -YEAR ADDITIONAL WARRANTY (BURNER CORE)**

In addition to the above mentioned one-year warranty, the Manufacturer warrants to the original purchaser of any Solaronics Suntube A.G.A./ CGA certified industrial heating gas-fired infra-red heater that it will at any time during the next nine years following the expiration of the original one-year warranty, furnish replacement of the burner core (the burner core consists of a specially designed 7.5" seamless spun metal vortex generator tube) exclusive of controls & tubing, F.O.B. Rochester, Michigan, which is proven to be defective in material or factory workmanship. The Manufacturer's sole obligation under this warranty shall be limited to furnishing a burner core. This nine-year additional warranty covers the burner core only and does not cover labor or transportation charges.

### **GENERAL CONDITIONS**

The warranties set forth in this letter are the exclusive remedy of the original owner user and are in lieu of all other warranties written, oral or implied (including any warranty of merchantability or fitness for purpose), and all other obligations or liabilities on the part of the Manufacturer, and the Manufacturer neither assumes nor authorizes any other person to assume for it any other obligation or liability in connection with the sale, installation or use of the heater or any parts thereof.

***The Manufacturer will NOT be responsible for LABOR CHARGES for analysis of a defective condition in the heater or for installation of replacement parts.***

The warranties provided herein will not apply if the input of the heater exceeds the rated input, as indicated on the name plate, by more than 5%, or if the heater in the judgement of the Manufacturer has been subjected to misuse, negligence, accident, impact, or abrasion, alterations by unauthorized service, operation contrary to the Manufacturer's instructions or if the serial number has been altered, defaced or removed. The Manufacturer shall not be liable for any default or delay in performance by it of these warranties caused by any contingency restraints, strikes, fire, flood or short or reduced supply of raw material, or parts.

Written permission is required for the return of any parts of equipment and any such return must be made on the basis of transportation charges prepaid. Shipments may be refused unless prior permission is obtained, and returned prepaid. This warranty applies only within the 50 United States of America and Canada.
